H. Pilot Requirements

2. **Pricing.** Pricing structure will be based on a transaction fee plus upfront costs to KCATA, if any. Costs should be clearly identified in the response in Attachment B. Respondent may require a revenue minimum for the pilot duration. Custom development is expected to be minimal during the pilot. Any required customization should be identified in the bid response. *Credit Card fees for transactions shall be the responsibility of and paid for by the Contractor.*

Following are an additional set of questions, submitted by potential bidders, and the answers:

Q1:	When does KCATA anticipate that the app will launch?
	RESPONSE: The timeframe will be mutually agreed to between the contractor and the KCATA. KCATA wants to ensure a successful pilot project so will work with the vendor on the schedule but with the mindset that time is of the essence needing to

	balance the 1 year timeframe and ensuring that there is sufficient time to have the mobile application in operation for testing and customer participation in the pilot.
Q2:	For pricing, will KCATA pay credit card fees for transactions or are vendors expected to cover these? Credit card fees represent a sizable expense for processing fare payments for transit agencies and will greatly determine our quote for the "Transactional Fee" section in attachment B.
A2:	Credit Card fees for transactions would be paid by the Contractor.
