**Item 1:**

RideKC Bus Decals 3M Controltac 180C & 8519 Laminate Size 6" x 26" with Comply Adhesive. The RideKC should match Pantone 301C. The icon and word "BUS" need to be Pantone 300C. ***Sample to be provided at time of bid submittal.***

**Item 2:**

RideKC.org diecut vinyl 3M Controltac 180C in white. Size 15.86" x 2.81" ***Sample to be provided at time of bid submittal.***

**Item 3:**

RideKC Bench Decal size 2.5" x 4", 3M 180C Controltac vinyl digitally printed. The bus icon should match Pantone 300C and "RideKC" should match Pantone 301C. ***Sample to be provided at time of bid submittal.***
