SUBMITTED QUESTIONS/ANSWERS

- Q. Under the section for: Type of Contract: Please clarify the wording “The term of this agreement shall include provision of the specialty wraps and installation services (or approved equals) specified herein for a period of three (3) months from date of contract award.” Please advise as to what these specialty wraps entail.
- A. **Delete Type of Contract and replace with: “Type of Contract: KCATA contemplates award of a firm fixed price contract.”**
- Q. Please confirm our registration with KCATA is current.
- A. **If you are already a registered vendor there is no need to resubmit the vendor registration from (Attachment A), EEO-1/Workforce Analysis (Attachment C) and Affidavit of Civil Rights Compliance (Attachment B) if submitted within the past two years. However, all other required certifications included in the RFQ must be submitted with the quote because this is a stand-alone RFQ.**

Q. Please provide samples of the following required products:

- Daily Forecast
- Text Discussion
- Warning Forecast
- Post-storm Report
- Snow Map

A. The forecast should at a minimum include the current conditions, precipitation detail, forecast detail and daily weather.

Q. For RFQ 5-6: Is there specific criteria which defines adverse weather questions and the subsequent requirement to (a) update the forecast; and (b) provide advance warning. If so, what are the specific criteria?

A. It is both A and B when the temperature gets to 34 degrees. Specific criteria is freezing temperatures (ground and air temperatures), rain and freezing rain, snow amounts and timing of snow in local areas North, East, South West sections of the metro area, tornado and flood warnings.
