The Contractor shall acknowledge in the proposal the receipt of this Addendum on the "Receipt of Addenda" form provided with Addendum #1 dated 8/23/2017.

CHANGES:

- 1. Section 2, "Scope of Work/Technical Specifications" shall be changed as follows:
 - A. Work Station 1:
 - a. Increase quantity from sixteen (16) to eighteen (18) each.
 - b. Work station shall consist of six rows, three similar workstations per row.
 - B. Work Station 2: Delete this requirement.
 - C. Storage 2: Increase quantity from two (2) to three (3) each.
- 2. Attachment H, "Bid Response Form."

Attachment H has been revised to reflect changes in Specifications and is attached. This revised document is to be included in your bid.

REQUESTS FOR CLARIFICATION:

1. Page 8, "Technical Specifications," Item E

The reference to Attachment M should be Attachment J. There is no Attachment M.

- 2. Page 8, "Technical Specifications," Item E
 - **Q: Storage 1:** This calls for Two 24 inch wide x 29 inch deep x 48-1/2 inch high "X-Series" file storage towers. Haworth "X" Series does not come in 24" width. Is this actually denoting the depth of the storage unit? If so, 18" is the standard depth. The widths can be 30 inch, 36 inch or 42 inch.
 - A: Storage 1: Two 30-inch x 18-inch x 48-1/2 inch high "X-Series" file storage towers.

3. Page 8, Technical Specifications," Item E

- **Q: Storage 2:** A standard Haworth "X Series" pedestal file is 15 inches wide x 24 inches deep. The specs call for 23 inches wide x 15 inches deep.
- **A:** Use the following dimensions: 15 inches wide x 24 inches deep.
- 4. Page 9, "Technical Specifications," Item E
 - **Q:** Will the sound masking speakers be installed in the above-ceiling plenum? What is the ceiling material mineral board, fiberglass, etc.?
 - **A:** The sound masking speaker are to be installed in the above-ceiling plenum. Regarding ceiling materials, bidders shall assume mineral board.
- 5. Pages 57-62, "Attachment J"
 - **Q:** Will you please provide the CAD plans for the space?
 - **A:** CAD drawings are not available at this time. Bidders should assume the furniture fits within the space as shown and walkways are ADA accessible. It is KCATA's intent to provide CAD plans to the successful low bidder prior to ordering the furniture.
