General Information

The KCATA has attempted to answer questions earlier than the answer period deadline with the previous addendums in order to allow all parties to process and respond to these questions and answer in a timely manner. But because of the workload of questions we have recently received from various transit agencies, the KCATA is extending the answers to question period from Wednesday, February 6, 2019 to Tuesday, **February 19, 2019**.

BID QUESTIONS/COMMENTS

Question: Request that the RFP closing date be extended a minimum of 3 weeks after receipt of KCATA's responses to questions, comments and request for clarification. This time is required to allow proposers time to review all responses and ensure this additional information is responsibly and responsively incorporated into proposals, to include requesting and receiving updated quotes from suppliers as appropriate.

Answer: The KCATA recognized that additional time may be in order to allow all competing suppliers to submit a comprehensive, accurate proposal. Please note this extension would be the second extension of the closing date, which was initially scheduled February 22, 2019 then moved to 2/25/19. The KCATA will **extend the closing date to March 8, 2019** which is 13 business days after the end of the adjusted answer period. The KCATA believes this is adequate time for all parties involved.
