2. Q: What is the source of funding and will any federal capital dollars be used?

A: The project is federally funded, and FTA regulations will apply.

3. Q: Will the program use co-branded marketing?

A: All vehicles and any marketing materials will not only need to be co-branded with the RideKC information, but will have to be approved and coordinated through KCATA for final say on the marketing activity and signage.

4. Q: Will the Agency consider using the vendors form agreement?

A: The KCATA agreement indicated in the RFP will be used.

5. Q: Are the digital/signatures/DocuSign acceptable for any signature requirements?

#### A: Yes

6. Q: Is the ride sharing program that currently has 17 vehicles in operation part of this RFP/program?

A: The current vehicles belong to the current service provider. If applicable, those vehicles will need to be transitioned over to the other vendor fleet – with a timeline/implementation plan.
