Q: Who is the current vendor/incumbent?

A: **GFL.**

Q: Can we have the current contract copy.

A: **Must submit a FOIA Request.**

Q: Is prevailing wage included in this contract?

A: **No.**

Q: What is the amount spent on the last 3 invoices?

A: **Approximately \$3000 – \$5500 total for the last 3 invoices.**

Q: What is the budgetary number for waste removal and disposal service in 2025?

A: **We do not release this information.**

Q: Are liquidated damages applicable to this bid? If yes, please specify the details.

A: **There were no liquidated damages specified in the scope of work.**

Q: Please advise the solid percentage for vacuum service?

A: **Up to 10%.**

Q: Please clarify what consists of “other liquid” waste. Can we have SDS for the same?

A: **The only liquids we have are anti-freeze, oil, diesel, gas and paints.**

Q: Please confirm if liquid waste and paint are already packed in drums?

A: **Yes.**

Q: Do you require empty drums to pack the waste?

A: **Yes.**
