**Bid Questions / Answers:**

**QUESTION 1:** A request has been made to extend the bid closing out at least one week from original bid closing of May 11, 2020 at 2:00 P.M.

**ANSWER:** The KCATA will extend the bid closing to Tuesday, May 19, 2020 at 2:00 P.M. Bids are to be mailed or dropped off to *1350 E 17<sup>th</sup> Street, Kansas City, MO 64108, Attention to "Andy Robichaud, IFB F20-5007-55A REBID."* There will be a public bid opening on campus in the Building 1 Small Conference Room.

Interested parties are encouraged (although not required) to participate with an online Zoom meeting or wait for the results of the opening in light of the COVID-19 outbreak. The in-person meeting must not exceed 10 persons at one time in the room.

**QUESTION 2:** A potential bidder wants to solidify the language in the IFB. Please ensure that will KCATA accept 2021 models if the 2020 models are no longer available for production?

**ANSWER:** Yes, 2020 and 2021 models that meet the specifications of the Scope of Work will be accepted.

**QUESTION 3:** Approved equals request: an agency has asked the KCATA to consider approving a 2020 Toyota Camry L model as an approved equal to the 2020/21 Chevrolet Malibu.

**ANSWER:** After reviewing the specifications of the vehicle, the Toyota 2020 Camry L varies in a few ways from the specifications of the IFB, but should meet the form, fit, and function of the vehicle bid.

The most critical parameters in which a 2020 Toyota Camry varies from the specifications in the IFB are detailed below:

KCATA's partnering agency believes that the core components of the Camry L meet or exceed the minimum specifications for this vehicle bid. The vehicle proposed must be white and free of excessive features not requested in the IFB

Other features found in 2020 Camry L vehicles that are available, (either as standard or optional features), that are present as minimum requirements within the IFB's specifications, such as airbags, wireless integration, and other features, are expected to be on the bid package at the time of bid closing.

Please note: the winning bidder shall be determined based on price, as long as the bid meets the minimum requirements of the specifications.
