REQUEST FOR CLARIFICATIONS

1. Q. Do you want arms on any of the 12 Game table chairs?

A. Please include arms on the table chairs.

2. Q. (No cloth material) is indicated on all seating. Do you have a preferred textile, i.e., real leather, simulated leather, or vinyl?

A. Simulated leather is the preferred option.

3. Q. Can pictures be taken of the space if needed?

There will be an additional opportunity to come measure and take pictures of the area, Friday October 21, 2022, at 1:00 PM. Please come to 1350 E. 17th St. (corner of 17th & Forrest), go to the blue guard shack and let them know you are here for a walkthrough. This will be the last opportunity to walkthrough the areas, no other opportunities will be offered.

4. Q. Is a sample of each seat type required if a presentation is requested?

A. Yes, a sample of each requested item is required during the second phase of the evaluation if your firm is selected to participate.

5. Q. Is this project Tax Exempt?

A. Yes, KCATA is a tax exempt, not for profit organization.

6. Q. What is the desired lead time or delivery date?

A. Delivery date is negotiable. However, KCATA prefers to take delivery as soon as the contract is awarded.

7. Q. Are substitutions allowed as long as we cover the specifications?

A. Substitutions or other options must be presented to KCATA for review first.

8. Q. Can we submit the bid proposal electronically?

A. Yes electronic submission is preferred, and the instructions for electronic submission is provided on page 2 of the RFP under proposal submissions.

9. Q. What is the exact delivery address?

A. The delivery address is 1350 E. 17th Street, Kansas City, MO 64108, Receiving Dock

10. Q. Can you clarify the cost breakdown again, please? Do you want the sell unit price to include only delivery or delivery and install?

The pricing proposal on page 47 of the RFP, asks for the price per item for each item requested, then that amount needs to be multiplied by the requested quantity to get the total price per item, the second table on the pricing page is where you will note the warranty cost for each item.

If you have a delivery cost, please make a note of the charge on the updated Price Proposal form at the bottom of this addenda.

11. Q. Does the product need to be of US origin?

A. No

12. Q. Do you require any specific company certifications?

A. No

13. Q. Is partial bidding allowed meaning can we quote only certain items? Do you intend to award just one vendor?

B. No partial bidding is allowed, KCATA intends to award this contract to a single vendor.
