  - A. Yes, standard aluminum rims are fine.
- Q. Please clarify if the base conversion is to be eqipped with a 3-passenger bench in the second row providing 1 w/c securement location, or if the base conversion is to be eqipped with two (2) single passenger fold-n-flip Seats in the second row providing 2 w/c securement location configuration.
  - A. 3-passenger bench seat with one (1) wheelchair securement location.
- 3. Q. Please confirm that this purchase will be made with FTA funds and will be subject to FTA terms and clauses For grant recipients. (Buy America?)
  - A. This procurement is not required to follow ADA compliance. 5310 subrecipients are not required to comply with all of the ADA accessible rules such as the provision for ADA complementary paratransit service.
- 4. Q. Request for Approved Equal: request to bid a Chevrolet Equinox or a Ford Escape.
