General Information

The following is KCATA's response to questions submitted by potential proposers.

IFB Questions:

- 1. Q. Due to 2022 chassis availability and 2023 chassis pricing not available until May/June time frame, we request the due date on this solicitation be extended until the pricing is available.
 - A. KCATA would not extend bid at this time. Vendors are encourage to provide their best possible pricing based on anticipicated price increase and delivery schedule/availability.
- Q. We request the following items be included in the specifications as "standard conversion equipment" in order to meet "Buy America" content. The rear entry requires careful selection of parts and components to meet the 70% required by Buy America.
 - a. 3rd row 2-passenger fold-away seat
 - b. Vinyl seat covers (black)
 - c. DOT kit (safety equipment)
 - d. Q'straint InQline for the forwardmost wheelchair securement position
 - e. Running boards (black)
 - A. Agree with #2
 - 3. Q. We also request the "safetytec" chassis option be removed from the specification. The "safetytec" package has a significant impact on the "Buy America" content. This option may prevent us from attaining the overall chassis/conversion content to meet "Buy America"
 - A. Agree with #3.
