**General Information**

The following is KCATA's response to questions submitted by potential proposers.

**RFQ Clarifications:**

1. Q. Side entry or rear entry ramp van?  
A. Side entry ramp van.
2. Q. Approve equal request: please accept a vertical stow ramp option in place of the manual in-floor ramp.  
A. No. We do not need a vertical stow ramp. Our population is not immobile.
3. Q. Approved equal request: please accept a side-entry conversion on a Chrysler Voyager.  
A. No. We do not need a side entry conversion.
4. Q. Approved equal request for the chassis. Requests the 2022 Chrysler Voyager LX model be approved in addition To the Toyota.  
A. The Chrysler Voyager LX is an approved equal.
5. Q. Request the specification be changed to ADA "compliant" in lieu of "accessible".  
A. This procurement is not required to follow ADA compliance. 5310 subrecipients are not required to comply with all of the ADA accessible rules such as the provision for ADA complementary paratransit service.
6. Q. Page 9 Table 1.1 I. Fuel System: exception to 20-gallon capacity fuel tank. The Chrysler Voyager LX has a 19-gallon fuel tank. The Toyota Sienna only comes with an 18-gallon fuel tank.  
A. The Chrysler Voyager LX fuel tank is an approved equal.
7. Q. Page 9 Table 1.1 II. Seating Type: request for approved equal. The Chrysler Voyager LX side entry has 1<sup>st</sup> row bucket seats, 2<sup>nd</sup> row 2 passenger fold seat, and 3<sup>rd</sup> row 3-person bench seat. Request this seating configuration.  
A. The Chrysler Voyager LX seating type is an approved equal.
8. Q. Page 10 Table 1.1 II. Floor Covering: approved equal request for full-length carpet flooring. Request non-slip Transit Flooring be approved as required for ADA compliance.

- A. Either flooring is acceptable. This procurement is not required to follow ADA compliance.
9. Q. Page 10 Table 1.1 II. Additional Features: approved equal request to delete Lane departure alert with steering assist. The Chrysler Voyager does not have this option available.  
A. Approved.
10. Q. Page 11 Section F. Delivery: upon receipt of order contractor will try to expedite a delivery of 4-8 weeks. However, with the current microchip shortage and delays in the supply chain in key areas of the transportation industry, a delivery within 8 weeks of an order cannot be guaranteed.  
A. The supply shortage is understood.
11. Q. The Toyota Sienna is only produced in a hybrid model. Please clarify if the hybrid is acceptable.  
A. No. The Hybrid is NOT acceptable.
