PROPOSER QUESTIONS/REQUSTS FOR CLARIFICATION

- 1. Q: What type of communication protocol are you currently using for the BAS (building automation system)? Is it Modbus? If so, what is the baud rate and type of connection required to your system? (ie: RS-232, RS-485, Ethernet, etc)
 - A: The vendor would need to contact C&C Group for information.
- 2. Q: Can you provide contact with C&C Group to work out the details of how the communication is set up?
 - A: Jerry with C&C Group at 913-530-7231.
- 3. Q. Would you like IR to provide a "system controller" to automate the compressor operation or do you still prefer the automation to be done on your end with the BAS?
 - A: A system controller can be provided as long as it ties into our BMS system.
- **4.** Q: Do you need compliance documentation referencing adherence to BAA?
 - A: Yes
- 5. Q: Has a leak study been performed in the system? If not, would you like IR to perform one so we can manage leaks in order to reduce load on the compressors and save you energy?
 - A: No leak study performed.
- 6. Q: Is there an ISO air quality requirement that is needing to be met for the air system? Basis your current system it appears you are operating as a 2.4.4

- 7. Q: Do you currently have Ingersoll Rand as a registered vendor?
 - A: Yes
- 8. Q: Are there any energy rebates from your utility you would qualify for?
 - A: None that we are aware of.

- 9. Q: Are there any energy efficiency plans or programs in place by KCATA that you need to adhere to?
 - A: No
- 10. Q: We understand the phasing in and out of the replacement is no longer a requirement and therefore the replacement can be done all at once, please confirm.
 - A: The replacement can be done all at once.
- 11. Q: Controls the line for integration to control system would help to be clarified. Are you looking to monitor (check for alarms?) or remotely control (start / stop / sequence etc.) the machines?
 - A: This is controlled via BMS
- 12. Q: Do not usually see controls integration in scope of supply on a project, it falls to the control or building automation vendor. If you still want this to be part of our scope, please indicate who your controls vendor is at this time so we can work directly with them on integrating these units into your controls network.
 - A: Jerry with C&C Group at 913-530-7231.
- 13. Q: Warranty do you just want pricing for extended warranty options? (Like when buying a extended new car warranty?) Or are you looking for a service agreement with others doing the actual maintenance (non KCATA personnel) with an extended warranty?
 - A: We do not know that we will actively pursue a warranty, but it is fine to price it out.
- 14. Q: Does everything need re notarized for this project from the previous issuance in 2020? Have all the needed documents notarized from project before but don't know if they will be accepted for this new project.
 - A: This is a new bid and all required documents must be notarized.
