

ACTIONS APPROVED BOARD OF COMMISSIONERS REGULAR MEETING JANUARY 25, 2017

Election of 2017 Board Officers

The Commissioners approved the Nominating Committee's recommendation of the following slate of Officers:

Consent Items:

a. Approval of Board Minutes

The Board of Commissioners approved the Minutes - December 21, 2016 regular Board meeting.

b. Ratify Exercising Option for Transfer Tickets

The Board of Commissioners ratified the final one-year extension option with Electronic Data Magnetics in and amount not to exceed \$115,200.

c. MOU Board of Police Commissioners

The Board of Commissioners approved Year Two of the MOU with the Board of Police Commissioners for salaries and benefits in an amount to exceed \$192,603.

d. Prospect Design Award

The Board of Commissioners authorized execution of a final design contract with Taliaferro and Browne for Prospect MAX in amount of \$2,260,101.

e. Banking Services

The Board of Commissioners authorized a one-year contract with four one-year options with Commerce Bank and resolution as recommended by staff.

f. Fasone Marketing Services

The Board of Commissioners approved \$152,292 additional funding to the contract in order to fund the work that has already occurred.

g. Point To Point Fiber Connection

The Board of Commissioners accepted the bid Point-to-Point Fiber Connection submitted by Consolidated Communications, Inc. and authorize Chairman to execute agreement for the period January 27, 2017 through January 26, 2020 in an amount not to exceed \$139,500.



h. Excess Workers' Compensation Insurance Renewal

The Board of Commissioners approved a one-year agreement for excess workers' compensation insurance effective February 1, 2017, with Safety National Casualty Company, with a premium of \$134,848.
